The Department of Community Affairs

(DCA) and New Jersey Housing and Mortgage Finance Agency (HMFA) recognize that many New Jersey families are currently going through or facing foreclosure. The State of New Jersey and the federal government provide a variety of programs to assist home owners. Information about these programs is free. As a service to struggling homeowners in the state, the DCA and HMFA ask that county governments please post the attached information on their websites. Also, counties are encouraged to share the flyers with visitors to their buildings and with any organization in their area that might find the information beneficial. For more information on foreclosure relief programs, please call 1-800-NJ-HOUSE. The DCA and HMFA appreciate any cooperation.

About Foreclosure — First Steps

Accurate information and a plan of action is KEY for homeowners either currently going through or facing potential foreclosure. The State of New Jersey and the Federal Government provide a variety of programs to assist homeowners. Information about these programs is FREE.

Here's all the necessary info you'll need to get started.

If you are in Foreclosure:

Contact the Office of the Courts Foreclosure Mediation Hotline at 888-989-5277 or visit <u>www.njforeclosuremediation.org</u>. This Foreclosure Mediation Program provides homeowners who are in foreclosure with access to housing counselors and court trained mediators to resolve foreclosure actions. A mediator and counselor will work with you and your lender to work out your mortgage so that your future payments will be affordable to you.

Review the <u>Federal and State Mortgage</u> <u>Modification Programs</u> available to you. There is NO FEE to get information about these programs.

If you are not in Foreclosure:

If you have missed a payment or payments or feel that you will soon miss a payment because your mortgage is no longer affordable to you, you should <u>call</u> <u>your mortgage servicer</u>. The number should be on your monthly <u>mortgage bill</u> <u>or coupon book</u>.

You may also contact a housing counseling agency in the county in which you live. See pages 3 and 4 of the <u>Foreclosure</u> <u>Fast Facts</u> (1.7MB PDF) (<u>Spanish ver-</u> <u>sion</u>) (2.2MB PDF) sheet for a list of counseling agencies. The counseling agencies listed here are non-profit, HUD certified and trained in foreclosure prevention.

There is never a fee to get assistance to work out your mortgage or to get information about the programs listed here from your lender or a HUD certified housing counselor.

The New Jersey Environmental Justice Alliance will conduct an environmental justice and cumulative impacts workshop and tour for Sustainable Jersey on September 25, 2012 in Camden.

A central concern of environmental justice is the disproportionate burden of pollution that has been widely documented in communities of color and low-income neighborhoods. Only recently have cumulative impacts been recognized by environmental policymakers as critical issues that must be addressed. Cumulative impacts involve multiple interacting sources of pollution that are inadequately controlled by our current laws and regulations.

The workshop will provide general information on both environmental justice and cumulative impacts, as well as involve workshop participants in a discussion of possible solutions for the problem of cumulative impacts in New Jersey. The workshop will end with a tour of several environmental justice neighborhoods in Camden.

Beware of any person or organization that asks you to pay a fee in exchange for housing counseling services or modification of a delinquent loan. Do not pay – walk away!

Beware of anyone who says they can "save" your home if you sign or transfer over the deed to your house. Do not sign over the deed to your property to any organization or individual unless you are working directly with your mortgage company to forgive your debt.

Never submit your mortgage payments to anyone other than your mortgage company without their approval.

If in doubt – do not pay and walk away.

If You Feel You Have Been the Victim of Mortgage-Related Fraud The Attorney General urges any member of the public who has been a victim of mortgage-related fraud to report it by calling the Division of Consumer Affairs' toll-free hotline at 1-800-242-5846. Consumers from out of state can call 973-504-6200. Those seeking to file a complaint can also visit the Division's website at www.njconsumeraffairs.gov.

If you feel you have been taken advantage of or misled by a lender, call Legal Services of New Jersey at 888-576-5529. Legal Services of NJ provides legal representation to low-income New Jersey homeowners.

Homeowners regardless of income level may file a complaint with the NJ Department of Banking and Insurance by calling 800-446-7467.

National Association of Counties (NACo)

NACo signs onto Supreme Court amicus brief in logging roads case

NACo signed onto the State and Local Legal Center's (SLLC) recently filed amicus brief in Decker v. Northwest Environmental Defense Center and Georgia-Pacific West, Inc. v. Northwest Environmental Defense Center. The U.S. Supreme Court will decide at least two related questions in this consolidated case affecting counties. First, do counties that own logging roads have to obtain EPA permits for channeled stormwater runoff off on logging roads? Second, who should regulate stormwater runoff from logging roads: state and local governments or the federal government?

The State and Local Legal Center's (SLLC's) amicus brief points out that obtaining EPA permits for every ditch and channel on every logging road in the United States would be extremely costly and burdensome for counties. Gloucester County Urges Residents to take steps to prevent West Nile Virus

The Gloucester

County Board of Chosen Freeholders would like to urge everyone to take steps to prevent West Nile virus infections. Outbreaks of West Nile virus disease occur each summer in the United States. This year, some areas of the country are experiencing earlier and greater activity.

• As of August 29th Gloucester County submitted four birds to the New Jersey Department of Health lab; one tested positive for West Nile Virus. Bird testing begins in mid April. The health department tests for crows and blue jays. The New Jersey Department of Health is finding other species of birds, such as raptors (e.g., hawks) and thrushes (e.g., robins), are also testing positive for WNV. The health department will continue accepting birds until the WNV season ends in late October.

• Residents who find a dead crow or blue jay on their property should contact the Gloucester County Department of Health at 856-218-4170 between 8:30 and 4:00pm for testing. Please keep in mind that birds that have deteriorated cannot be tested. The health department will ensure transportation of all specimens to the state lab for rapid testing and results.

Gloucester County Public Works Mosquito Division continues to remain vigilant regarding the testing of mosquito pools for West Nile Virus. This information helps them focus their efforts on specific target areas for pesticide applications.

West Nile virus is transmitted to people by infected mosquitoes. In the United States, most people are infected from June through September, and the number of these infections usually peaks in mid-August. Seasonal outbreaks often occur in local areas that can vary from year to year. Many factors impact when and where outbreaks occur, such as weather, numbers of mosquitoes that spread the virus, and human behavior.

Awareness is the strongest weapon regarding West Nile virus activity, and our goal is to provide residents with the actions to protect themselves and their family.

Prevent mosquito-borne diseases:

When outdoors, apply an EPA registered insect repellent to exposed skin, like those containing DEET, picaridin or oil of lemon eucalyptus, according to the instructions on the product label. Permethrin can be used to spray clothing and gear.

Also, to avoid mosquitoes, remember they are most active between dusk and dawn, so limit time outside during those hours or wear long sleeve shirts, long pants and socks sprayed with repellent while outdoors.

Mosquitoes begin to breed in any puddle or standing water that lasts for more than four days.

Get rid of mosquito breeding sites around the home by:

- Cleaning out gutters and drains
- Disposing of old tires
- Draining standing water from pool covers and ditches
- Removing all containers that hold water
- Maintaining pools, spas and saunas properly
- Changing birdbath water every several days
- Making sure all windows and doors have screens and that all screens are in good condition

Remember, the best way to prevent West Nile virus disease is to avoid mosquito bites. Approximately 1 in 5 people who are infected with West Nile virus will develop symptoms which may include:

- Fever, headache, body aches, joint pains, vomiting, diarrhea, or rash.
- Less than 1 percent will develop a serious neurological illness such as encephalitis or meningitis (inflammation of the brain or surrounding tissues).
- People over 50 years of age and those with certain medical conditions, such as cancer, diabetes, hypertension, kidney disease, and organ transplants, are at greater risk for serious illness.

There are no medications or vaccines to treat or prevent West Nile virus infection. People with milder illnesses typically recover on their own, although symptoms may last for several weeks. In more severe cases, patients often need to be hospitalized to receive supportive treatment, such as intravenous fluids, pain medication, and nursing care. Anyone who has symptoms that cause concern should contact their health care provider.
