Agencies Generate More Revenue With GovDeals

Government agencies across the US and Canada are looking for innovative ways to generate more revenue and avoid layoffs due to budget cuts. More than 4,300 of these agencies have turned to GovDeals.com, leading the online government auction site, to sell their surplus and confiscated items. GovDeals is designed to enable governmental entities and their agencies the ability to sell surplus and confiscated vehicles, assets, property, and equipment over the Internet. GovDeals provides access to a pool of 297,000 bidders in the US and 110 other countries as well as 1.6 million bidders from other Liquidity Services market places. To date, GovDeals clients have generated over \$500 million for items that were no longer in use. These items include old office furniture, fleet vehicles, and heavy equipment.

Hackensack, New Jersey has been using GovDeals.com to sell surplus property at online auction since August 2007. In that time 58 items have been sold generating 743 bids and bringing in almost \$104,000 in revenue. Of the Top 10 bid items for Hackensack, only three buyers came from New Jersey. Three other bidders were from Pennsylvania, Florida, Georgia, Illinois and Maryland. The average distance traveled by the Top 10 bidders was over 380 miles and one bidder travelled 1,298 miles from Miami, Florida to purchase a 2004 Ford Crown Victoria.

In addition to creating revenue, agencies are using GovDeals.com to avoid costs. The State of Georgia began using GovDeals in November 2004 for surplus property disposition. They are responsi-(*Continued on page 3*)

ble for surplus of the Department of Transportation, Higher Education, and all State agencies. To date, more than 4,300 items have been sold generating \$5.3 million in revenue and 103,000 bids. While most of the surplus was sold to bidders in Georgia, buyers came an average distance of more than 170 miles away to buy the State's surplus property. In all, 37 US States were represented by the bidders.

In February 2011, the State of Georgia and the University of Georgia Agricultural Research Department were responsible for the disposition of The trees were still in the 584 mature trees. ground and had to be dug up and hauled away. In order to avoid the removal and logistics costs they placed the trees up for auction on GovDeals.com. The trees were divided into seven lots, by species, with special instructions that the winning bidder would need to be equipped to extract, back fill all the holes and haul the trees from the premises. "We were hoping to get about \$2,000 for all seven lots combined," said Steve Ekin, Director of Surplus Property Division. Instead, the trees sold for a total price of \$7,975. "Because of GovDeals's Marketing efforts and large audience of buyers, we were able to get eight times the return on these trees than we expected." All 584 trees were purchased by a bidder in Nesbit, Mississippi; 407 miles away.
