As part of this restructuring initiative, most of Valley's 204 branches will receive technology upgrades to streamline and enhance the customer experience, while improving efficiencies by lowering operating costs. These upgrades include:

- Interactive Video Teller Machines These automated machines will be available in branch lobbies 24/7, giving customers remote access to banking professionals via video conference and help them perform complicated transactions for a highly personalized experience. This allows the customer the ability to choose live face-to-face assistance, as well as discuss other products and services to suit their banking needs.
- Enhanced Full Service ATM This machine accepts cash and check deposits differently than a traditional ATM. Instead of using an envelope and entering the deposit amount on the keypad, cash is inserted into a slot labeled "Cash" and checks are inserted into another slot labeled "Checks". The ATM then counts the items and totals the deposit, providing an image of each check and an itemized list of bills deposited by denomination.
- Enhancing Digital/Online Capabilities Valley is integrating technology upgrades to its mobile banking

United Water Offers Tips to Help Prevent Freezing Pipes

United Water officials are advising homeowners how to help avoid frozen pipes and water meters during this severe cold weather. But, even if freezing should occur, there are steps that can be taken to remedy the problem.

It is extremely important to insulate household piping to protect against cold drafts in unheated spaces. Even a small draft can cause freezing. The water company is responsible for service lines only to the curb. It's the homeowner's responsibility to protect all piping inside the property lines - as well as the water meter - from frost damage. Freezing temperatures can destroy a meter, which would have to be replaced at the customer's expense.



Partial water service in a home indicates that the freeze is located in a pipe somewhere in the house. A complete lack of water service can be the result of a frozen water meter or a frozen pipe leading from the water main in the street to the house. A meter or water pipe that feels extremely cold is most likely frozen.

It's important to clear frozen blockages as soon as possible to minimize the danger of pipes bursting in some inaccessible spot. The resulting leak could cause serious property damage. Thaw pipes and meters by applying hot air from a hair dryer, electric heater, or by using a heating pad. Open a water valve slightly so that it will be apparent when thawing has occurred. Under no circumstances should hot water or a blow torch be used on a frozen pipe or water meter. The intense heat could cause the very break the customer is trying to prevent, and a blow torch presents a serious safety hazard.



The permanent solution to frozen water lines is proper insulation to protect them from drafts of cold air. Water meters located in unheated cabinets, garages and basements can be wrapped in insulating materials or even newspapers as a temporary measure. Pipes exposed to severe temperatures can be wrapped with heating tape which can be purchased at most hardware stores.

In its report, the Joint Commission found the Essex County Hospital Center had passed all areas of its inspection and "there were no requirements for improvement identified."

The Joint Commission conducted its unannounced inspection from July 15 - 19 and a follow-up visit on December 17 and 18 to assess compliance with the Medicare conditions for hospitals, as well as the special conditions for psychiatric hospitals through the Joint Commission's deemed status survey process. Based on the findings of the Joint Commission, the Essex County Hospital Center was awarded three-year accreditation on December 18th. The Essex County Hospital Center has been an accredited facility since it opened in 2007, having received three-year accreditation status in 2007, 2010, and now 2013.

Since 2003, Essex County Hospital Center had a clear mission to provide evidence-based care to promote patient recovery and return to community living. The Hospital Center has a well-organized discharge-planning process that ensures all discharges are appropriate and timely. Indeed, the Hospital Center has been able to reverse the trend of overcrowding with a significant reduction in the number of discharge-ready patients who cannot leave because they are waiting for placement.

Opened in February 2007, the Essex County Hospital Center's new, state-of-the-art facility provides patients with comfortable accommodations and staff with modern and efficient work areas. The American Medical

Association has approved the Essex County Hospital Center as a facility in which physicians can receive continuing education credits. The Essex County Hospital Center has shared services agreements to accept patients referred by the State, Middlesex, and Passaic Counties which generates about \$13 million a year in recurring revenue.

The Joint Commission is an independent, not-for-profit organization that accredits and certifies more than 20,000 health care organizations and programs in the United States. Joint Commission accreditation and certification is recognized nationwide as a symbol of quality that reflects an organization's commitment to meeting certain performance standards.

Nationwide Economics Weekly Economic Review & Outlook for January 6, 2014

The economy enters 2014 on a bit of a roll

Weekly Review

The first reports of the new year suggest that the U.S. economy ended 2013 on a solid note. The Institute of Supply Management (ISM) manufacturing index slipped slightly in December to 57.0 from 57.3 in November, but his was still the second best print of the past two years and marked the seventh straight time the headline figure has come in ahead of consensus expectations. Moreover, the small decline owed largely to a drop in the inventory component, which fell back into contraction territory for the first time since August. In contrast, then new orders, employment, and supplier delivery time indices all rose last month and are at levels reflecting broad expansion. The new orders component is especially important, as it is viewed as a leading indicator of the employment and production components. The production index also remains well into growth territory even after it pulled back a bit in December. The upshot is that the manufacturing recovery is bordering on robust at the moment, reflecting a broader economy that is increasingly finding firm footing.

The same is true to varying degrees in many other parts of the world. Markit's index of factory activity for the eurozone rose to a two-and-a-half year high in December on big jumps in Germany and Italy. Even Greece's index is now on the verge of moving into expansion territory after hitting its highest level since 2009 last month. The European economy continues to stabilize and is slowly beginning to gather steam. The better global economy is, in turn, feeding back into U.S. exports, manufacturing, and employment.

As these and other feedback loops have strengthened, a stronger expansion has become ever more convincing. Consumer confidence measures were generally up strongly in December on sizable jumps in expectations. Additionally, with the labor market continuing to recover and wealth effects from rising home prices and equity values broadening, there remains plenty of upside to sentiment from here. For example, the Conference Board's index of consumer confidence, which currently stands at 78.1, has risen well into the triple-digits in every expansion since the 1960s - save the anomalous one-year recovery of 1980-81. Sentiment appears to be inevitably moving in the same direction in this cycle and its continued turnaround will play a key role in ushering in the next phase of the expansion. Growing confidence will lift spending, profits, and investment and help to keep the rally in risk assets afloat. The broad economic growth rate has been sub-par since the recession ended in 2009, but there is a case to be made that the transition to a more normal pace of expansion will unfold in 2014. Moreover, given the upward trajectory of economic indicators toward the end of last year, suggesting significant forward momentum, the risks to the outlook are tilted more toward the upside in 2014 than to the downside.

Weekly Outlook

Aside from the important December employment numbers, it will be a light week for economic releases.

Job growth has shifted higher in recent months, averaging gains of 204,000 per month since August. After posting declines earlier in the year, goods-producing sectors (particularly manufacturing and construction) are adding jobs again, a good sign for the overall health of the labor market. The recent improved trend should continue in December with job growth of 205,000 projected and with the potential for slight upward revisions

in previous months. Reflecting the rise in job growth, the unemployment rate fell to a post recession low of 7.0 percent in November. In part due to a small rise in the participation rate, we expect the unemployment rate to be unchanged in December despite stronger job growth.

The ISM non-manufacturing index has fallen sharply since posting a post-recession high in August as all sub-components have weakened, although it remains comfortably above the break-even level of 50. The index is likely to recover modestly in December o a level of 54.5 (suggesting modest expansion) as the service sector's new orders and employment rose a the end of the year.

Improved economic growth abroad (particularly in Europe) is raising demand for U.S. exports - now up by 5.5 percent over the past year. In spite of this, the U.S. trade deficit has remained close to the yearly average of -\$40.2 billion due to increasing imports (in response to stronger domestic growth). The trade deficit is likely to fall below the year average in December as exports end the year strongly.

Sheriff's Office Collects 1,491 Pounds of Unwanted Medicines

A total of 1,491 pounds of unused and/or outdated prescription and over-the-counter medicines were collected through various programs in 2013: Rx Mission Drive-In/ Drop-off events held at five scheduled Household Hazardous Waste (HHW) Day events, at a drop-box outside the Sheriff's Office, through the Sheriff's Office annual participation in Operation Take-Back Day and through a consortium with the Sheriff's Office, EmPoWer and Safe Communities Coalition of Hunterdon and Somerset, to collect medications from several senior centers and facilities.

"The Somerset County community has consistently stepped up and taken a proactive approach toward protecting the environment, and the success of these programs drives that point home," said **Somerset County Sheriff Frank J. Provenzano**.

"Residents dropped off a total of 594 pounds of medicines at the March, April, June, September and October HHW events. Also, in October, 35 pounds were collected through the Operation Take-Back Day drop-off program, which the Sheriff's Office participates in annually.

"According to a national study, 70 percent of people who reported using prescription drugs for non-medical use in the past year got those medicines from a home medicine cabinet, friend or relative," he said. "Thanks to our residents' efforts, the incidence of this happening has been reduced substantially."

Drop-off events prevent unused or expired medications from being flushed down toilets and sinks or discarded in landfills, which can lead to potential contamination of groundwater and/or wastewater treatment plants. They also keep drugs out of the hands of people susceptible to substance abuse and prevent accidental poisoning by children.

Sheriff's Office Collects 1,491 Pounds of Unwanted Medicines

In addition to scheduled drop-off events, residents wishing to dispose of medications year-round can do so by dropping them off at the Sheriff's Office medicine collection drop box, 24 hours a day, 7 days a week. The drop box is located in the lower level of the Somerset County Administration Building at 20 Grove St. in Somerville, near the entrance to the Sheriff's Office. In 2013, a total of 708 pounds of medications were dropped off at the medicine collection box.

Also, through the consortium, 154 pounds of unwanted medications were collected from participating locations by the Sheriff's Office for proper disposal.

"Drug-collection programs, which are free and anonymous -- no questions asked -- have proved to be a huge success in Somerset County," said Sheriff Provenzano. "For our community's safety, I look forward to supporting them in the future."

Automated labor tracking provides a greater adherence to a wide array of labor laws and union policies, including ACA, with detailed, auditable reporting in real-time.

The Affordable Care Act (ACA), which took effect this month, requires all Americans by law to have health insurance. Mercer County's next ACA seminar, "Health Insurance 101: What you Need to Know About the Affordable Care Act," will be Tuesday, January 21st, from 6p.m. to 7p.m. at County Connection in Hamilton. Attendees will be given advice on how to navigate the system, understand the new healthcare choices, learn how to enroll and understand how the new Act affects families, small businesses, young adults, early retirees and people who work for themselves. The information session is free of charge.

"Navigating the Affordable Care Act process can be confusing for some," said Hughes. "By offering this seminar, we hope to shed light on how the ACA can help people who might not otherwise have health insurance."

Online Toolkit Helps with Pension Funding Changes

The Governmental Accounting Standards Board (GASB) has released a new online toolkit that will help preparers and auditors of state and local government pension plans to implement new accounting and financial reporting standards. The toolkit provides guidance on how plan administrators can effectively comply with the new rules. It includes the following resources:

- An authoritative resources guide to GASB Statement 67 implementation for pension plans
- A video addressing the top implementation issues facing pension plans
- A podcast discussing the types of pension plans that will be affected by Statement 67 and the most significant changes to accounting and financial reporting
- A background document answering frequently asked questions regarding Statement 67 and Statement No. 68, Accounting and Financial Reporting for Pensions
- A fact sheet answering frequently asked questions specifically related to Statement No. 67
- An article identifying several areas plan administrators and public officials should consider as they plan, prepare, and collaborate when implementing the new standards
- A "Setting the Record Straight" document addressing misperceptions about the new standards; and
- The executive summary and the full text of GASB Statement 67

The new standards include Statement No. 67, Financial Reporting for Pension Plans, which applies to financial reporting by most pension plans and Statement No. 68, Accounting and Financial Reporting for Pensions, which applies to financial reporting by most governments that provide their employees with pension benefits. Some highlights of the new rules include the redefined pension plan to reflect the principal actions associated with the pension arrangement - shaping pension, collecting and handling assets reserved for pension, and paying benefits to plan members as they come due.

In addition, the Government Finance Officers Administration has put together an Elected Official's Guide to the new pension accounting requirements. These changes to how state and local governments account for the cost of pension benefits in their financial statement are clearly explained for those with little or no expertise in pension accounting in the new guide - <u>An Elected Official's Guide: The New Pension Accounting.</u>

Gloucester & Salem Counties Share Health Officer

Shared Service will save Gloucester County \$72,000 a year

Gloucester County Freeholder Director Robert Damminger and Freeholder Adam Taliaferro announced today that Gloucester County and Salem County will enter an agreement to share a Public Health Officer.

Annmarie Ruiz, a licensed Public Health Officer who has been employed as Gloucester County's Health Officer since 2012, will share her responsibilities equally with Salem County and serve in a dual capacity. Gloucester County will maintain the employment of Ms. Ruiz and Salem will reimburse Gloucester County fifty percent of her salary and benefits.

Freeholder Director Robert Damminger said, "This shared service is a benefit to both counties for achieving coordinated public health goals and outcomes. Both counties have an existing support infrastructure that makes it possible for us to share this position and both counties have a history of working very well together to share services to save tax dollars."

New Jersey requires County Departments' of Health to have a licensed Public Health Officer. They serve as lead liaison between the County Health Department and the State Department of Health, and are responsible for preparing reports and establishing and maintaining related files and records.

The Health Officer, through contract with the local municipal boards of health, serves as the general agent for the enforcement of their health ordinances and health laws of the state. The Health Officer participates in evaluating public health services, problems and needs, works with community groups to help them to recognize their public health problems and concerns and comes up with methods and a general plan to help solve issues.

Freeholder Adam Taliaferro said, "Sharing a Health Officer is about more than dollars and cents, Gloucester and Salem County share many of the same health concerns. The goal of public health is to improve the health of the public and we have many tools that identify and prioritize health issues and strategies. Together we can work on programs that help promote immunizations, healthy eating and exercise and increase awareness about existing health services." Taliaferro is the Liaison to the Department of Health and Human Services for Gloucester County.

Gloucester County will vote on the shared services agreement at the January 22nd Freeholder Meeting, and Salem County is scheduled to vote in January. Salem will pay Gloucester County \$72,680.00 for the first year of this contract in equal monthly installments.
