This presentation will focus on key provisions, with a specific focus on how each item may impact county governments. The analysis covers eligibility criteria for the use of funds, compliance and financial reporting, and key dates for county actions. This report also highlights several key differences between the ARPA county aid and the previous county aid under the CARES Act's Coronavirus Relief Fund.

HISTORIC TRUSS BRIDGE REHABILITATION

The educational objective for the audience of this presentation is to understand the engineering design and construction challenges associated with the preservation and rehabilitation of historic trusses. The session will highlight the rehabilitation of an 8-panel, Pratt through-truss, constructed in 1880 by the Cleveland Bridge and Iron Co. The existing 103-foot-long, 17-foot-wide steel truss bridge was structurally deficient due to the 6-ton posting, and functionally obsolete due to the 15-foot-wide, one lane roadway and a 13'-6" restricted vertical clearance. The bridge was identified as eligible for listing on the National Register of Historic Places and presented many challenges that the session will address.

Planning for reentry from jail is challenging under normal circumstances but is even more challenging when people are admitted and released within days.
