Purpose

- This presentation will provide an overview of the Distributor and J&J opioid settlement agreements, as well as the State Subdivision Agreement, pursuant to which approximately \$641 million in opioid settlement funds will be paid to the State and local governments through 2038.
- It will also address "Approved Uses" for opioid settlement funds and recommendations on the treatment, prevention, and other strategies to combat the opioid epidemic.



Distributors & J&J Settlement Agreements OVERVIEW

- Nationwide settlements reached to resolve all opioid litigation brought by states and local political subdivisions against distributors (i) McKesson, Cardinal Health and Amerisource Bergen (collectively, "Distributors"), and (ii) manufacturer Janssen Pharmaceuticals, Inc. and its parent company Johnson & Johnson (collectively, "J&J").
- Culmination of almost three years of intense negotiations.
- Not a class action "opt out" settlement; required a "critical mass" of participation.

TRENTON – Acting Attorney General Andrew J. Bruck announced today that all 21 counties in New Jersey, and all 241 municipalities that have populations over 10,000 or that filed related lawsuits, have joined the State in signing onto the nationwide settlement agreements with Johnson & Johnson and the country's three largest pharmaceutical distributors – McKesson, Cardinal Health, and AmerisourceBergen – to resolve claims involving their roles in fomenting the country's opioid crisis.

As a result, New Jersey and its counties and municipalities are on track to receive the maximum amount available to the State under the settlements: over \$641 million. Under the settlements, the amount that each state will receive depends on the level of participation among its county and municipal governments that have populations over 10,000 or that have filed lawsuits against the companies. New Jersey has now achieved 100 percent participation among those counties and municipalities.

DISTRIBUTORS Payment Amount & Schedule

- Global Settlement Amount of \$21 billion over 18 years:
 - Global Settlement Abatement Amount totaling \$19,045,348,616;
 - Global Settlement Attorney Fee Amount totaling \$1,671,923,077; and
 - Additional Restitution Account totaling \$282,692,307.70.

- New Jersey Settlement Allocations:
 - NJ Net Abatement Amount = 2.7551354545%.
 - NJ Abatement Amount = \$511,188,209.44
 - NJ Additional Restitution Amount = \$12.37 million.

J&J Payment Amount & Schedule

- Global Settlement Amount of \$5 billion over no more than 10 payments:
 - Global Settlement Abatement Amount totaling \$4,534,615,385.00;
 - Global Settlement Attorney Fee Amount totaling \$398,076,923; and
 - Additional Restitution Account totaling \$\$67,307,692.



Intrastate Allocation

- Intrastate allocation or how to allocate the settlement funds between the state and its subdivisions can be set by one or more of the following:
 - Default Under the Agreement
 - State-Subdivision Agreement
 - Allocation Statute or Statutory Trust



Titled: "MEMORDANUM OF AGREEMENT BETWEEN THE STATE OF NEW JERSEY AND LOCAL GOVERNMENTS ON OPIOID LITIGATION RECOVERIES"

Purpose: "[T]o establish binding terms for the distribution and spending of funds from any National Opioid Litigation Resolution that is a settlement agreement and – at the sole discretion of the State – any National Opioid Litigation Resolution that is a bankruptcy plan."

State Subdivision Agreement - Overview

Allocation of Opioid Settlement Proceeds

 All Opioid Funds shall be divided with 50% directly to the State ("State Share") and 50% directly to the Participating Local Governments ("Local Government Share")



Allocation of Opioid Settlement Proceeds Among the Subdivisions

Allocations are subject to change pursuant to a State-Subdivision FINAL AGREEMENT Agreement, Allocation Statute, Statutory Trust, or voluntary redistribution. 3.10.22

Voluntary Redistribution

- If that Participating Local Government is a municipality, that municipality's funds shall be reallocated to the Participating County in which it is located.
- If the county in which such municipality is not a Participating County, then that municipality's funds shall be reallocated proportionally among the Participating Counties.



Opioid Remediation & Approved Purposes

- "Approved Purposes"
 - Those uses identified in the Opioid Abatement Strategies attached as Exhibit A (which is Exhibit B to the national settlement with the Settling Distributors) or such equivalent in other National Opioid Litigation Resolutions.
 - All Opioid Funds, except those allocated to payment of administrative expenses as set forth in Section C(3) if permitted by the relevant National Opioid Litigation Resolution, and counsel and litigation fees and expenses to the extent permitted in Section D and the relevant National Opioid Litigation Resolutions, shall be utilized in a manner consistent with the "Approved Purposes" definition.

- OPIOID FUNDS SHALL BE USED TO SUPPLEMENT AND SHALL NOT SUPPLANT FEDERAL, STATE, COUNTY OR MUNICIPAL FUNDS, AS THE CASE MAY BE, THAT OTHERWISE WOULD HAVE BEEN USED FOR APPROVED PURPOSES.
- NO AMOUNT OF SUCH MONIES SHALL BE USED TO REIMBURSE THE STATE OF ANY OF ITS COUNTIES OR MUNICIPALITIES FOR PAST EXPENDITURES, EXCEPT AS MAY OTHERWISE BE REQUIRED TO REFUND TO THE FEDERAL GOVERNMENT A PORTION OF THE MONIES.
- NEITHER THIS PROVISION, NOR ANY OTHER IN THIS AGREEMENT, SHALL BE INTERPRETED TO PREVENT OR PROHIBIT EITHER THE STATE OR ANY LOCAL GOVERNMENT FROM MODIFYING, CHANGING OR TERMINATING ANY OPIOID ABATEMENT RELATED PROGRAMS WHEN, IN THEIR RESPECTIVE JUDGMENTS, CHANGING CIRCUMSTANCES AND CONDITIONS MAKE SUCH CHANGES OR MODIFICATIONS APPROPRIATE.

SUPPLEMENT, NOT SUPPLANT

Administrative Expenses



No more than five percent (5%)
 of the State Share and no more
 than five percent (5%) of the
 Local Government Share may
 be spent on administrative
 expenses.

Supplemental Contingency Fee Fund



Consistent with the State Subdivision Agreement, 3.25% is taken off the top of the New Jersey Local Government Share from the first seven payments for the Supplemental Contingency Fee Fund to cover litigating subdivision counsel's fees.

County Advisory Council

- County's Health Department
 - Lead agency responsible for distributing Local Government Share;
 - Shall consult with an advisory council (the "County Advisory Council"), whose purpose is to provide input, advice and recommendations on the disbursement of such monies across Approved Purposes.

Reporting & Accountability

- At least annually, <u>by September 1st of each year</u>, each Region shall provide to the State a report detailing for the preceding state fiscal year, in the manner and form prescribed by the State:
 - The amount of the Local Government Share received by each Participating Local Government within the Region;
 - 2. The allocation of any awards approved (listing the recipient, the amount awarded, the program to be funded and disbursement terms);
 - 3. The amounts disbursed on Approved Purposes; and
 - 4. The amounts sent on administrative expenses.

There have been two Distributor payments to date:

1.July 15, 2022 = \$24,663,923.93

2.October 31, 2022 = \$27,896,349.33
