

### A Renewed Need For COVID Testing



As we near the two-year anniversary of the first case of COVID in the United States and face an imminent wave of the new Omicron variant, the need for reliable testing infrastructure continues to be paramount.

New Jersey residents can be grateful that Governor Murphy and Health Commissioner Persichili have invested in a program to provide easy and reliable access to free COVID testing, whenever they need it. The new <u>at-home testing program launched this month</u>, providing at-home COVID-19 saliva testing for any person who believes they need to be tested, with or without symptoms,



right to your door, with quick results.



For public health officials, this program also offers access to critical information used to learn more about the spread of the virus and how to stop it.

As Omicron - the latest variation of COVID-19 spreads across the world, epidemiologists are relying on PCR tests to examine the genetic makeup of the virus and its rate of spread. While antigen or rapid tests offer an immediate positive or negative result (particularly useful for people with symptoms who need an immediate answer), they provide no information to public health about how the multiple variants are spreading across communities. Vault's PCR test makes this genetic analysis possible, which is how the first cases of Omicron were detected in the United States and how public health officials will study this new strain to learn how transmissible it is and how vaccinated and unvaccinated affects differently.

# How Nevada County, CA, Is Using Zencity And Community Feedback Data For Performance Management

#### Introduction


Nevada County's leadership regularly uses Zencity as a performance management tool, continuously <u>measuring</u> <u>resident satisfaction levels</u> to identify and track community trends and sentiment. As the county navigates major strategic challenges, like Covid vaccine rollouts, performance management based on community feedback data has been a key part of the County's success.

### The Challenge

At the start of 2021, Nevada County, CA, like many counties around the nation, launched its Covid-19 vaccine operations. With limited doses for eligible community members and no clear guidelines yet set by the <u>California Department of Public Health</u>, the County had to determine how to prioritize vaccines and resident eligibility. The County decided – uniquely and with no state mandate to back it up – that it would vaccinate educators first, followed by healthcare workers, the elderly, and vulnerable populations. The County wanted to understand how community members felt about its strategic prioritization. Were they aligned? Was the County's approach to vaccinations on the right track?

#### The Zencity Solution

County management turned to Zencity to answer these questions and determine the best plan of action moving forward by monitoring resident discourse and analyzing sentiment in the County's Covid-19 Vaccine Project dashboard.




### **Impact**


The Nevada County government's Zencity dashboard showed that the public's reaction to the County's vaccine strategy and prioritization was favorable; from December through April, **positive sentiment from resident's online discourse towards the County's vaccine messaging measured more than 4x higher than negative sentiment**. Shortly after, the State followed with a mandate to allocate a certain number of vaccines to educators which was not only exciting, but further validated the national push for prioritizing vaccines for educators.

Zencity's insights drilled down into the data to further validate the County's approach – showing that the main driver of positive sentiment was specifically the County's strategic prioritization – not just positive sentiment about vaccines generally.



Ultimately, by using Zencity as a performance management tool and monitoring community feedback, County leadership was able to determine that its **vaccination strategy was unwaveringly well received**. With the data to back this up, County leaders then **confidently approached elected officials and stakeholders to get them on board with its prioritizations of limited vaccines**.

# **Hackensack, New Jersey Pursues Digital Transformation**

A transition from paper to digital processes is underway in Hackensack, New Jersey where local officials have sought greater efficiency in municipal operations and constituent services. # **Commissioners Join Coalition To Make Polluters Pay For Climate Costs**

How do we pay for it all? That is often the biggest challenge facing county officials tasked with protecting their constituents and communities from the damaging floods, rising seas, and storms from Sandy to Ida that are becoming worse and more frequent because of climate change.

Reinforcing coastal defenses, elevating roads, upgrading sewer and stormwater systems — all these desperately needed projects come with enormous and sometimes insurmountable price tags, especially for communities that have limited resources and tightening budgets.

But a growing coalition of officials in New Jersey and across the country believes that taxpayers should not be stuck footing the bill for climate change alone. Instead, they argue, the corporate polluters that profit from the fossil fuels that drive climate change should be held accountable to clean up their mess and pay their fair share of the costs.

<u>Leaders for Climate Accountability (L4CA.org)</u>, a project of the nonprofit Center for Climate Integrity, now features more than 100 elected officials across the U.S., with 11 in New Jersey, including Essex County Commissioner Brendan Gill, Atlantic County Commissioner Caren Fitzpatrick, and Union County Commissioner Al Mirabella.

Leaders for Climate Accountability is expanding its membership as a growing number of states and localities are taking or considering legal action to recover the spiraling local costs of climate change from major oil and gas companies that have lied to the public about the dangers of their products and opposed climate action for decades. Widespread evidence, recently highlighted by an ongoing congressional investigation, shows that executives at ExxonMobil and other companies were warned as early as the 1970s that their products could cause "catastrophic" damages, but they instead funded climate denial to protect their profits, leaving residents to pay the price.

Last year, the City of Hoboken, under the leadership of Mayor Ravi Bhalla, a member of Leaders for Climate Accountability, became the first New Jersey municipality to take Exxon and other major fossil fuel companies to court to hold them accountable for causing the crisis — and to make the polluters pay their fair share of the resulting costs.

Atlantic, Hudson, and Union counties; the municipalities of Atlantic City, Asbury Park, Bradley Beach, Maplewood, Red Bank, and Sea Bright, and the New Jersey League of Municipalities, have all passed their own resolutions calling on Governor Murphy and the attorney general to take similar legal action.

Recent presentations at the Association of Counties' "Summit on Natural Disaster Response and Recovery" in December made clear that the need to make our communities more resilient against climate threats will only become more urgent and expensive. Federal and state officials have estimated that protecting against back bay flooding could cost \$16 billion. A 2019 Center for Climate Integrity study estimated the state's bill for seawalls could be as high as \$25 billion by 2040.

# Division on Women's Address Confidentiality Program: A Vital Resource For Stalking Victims/Survivors

January is Stalking Awareness Month. As you know, abusers use stalking to terrorize, threaten and exercise control over people they know, as well as people they don't know.

#### Studies have shown:

- **Stalking is common.** About 1 in 6 women and 1 in 17 men have experienced stalking in their lifetimes.
- There is a large connection between stalking and intimate partner homicide. 76% of women murdered by an intimate partner were also stalked, and 85% of women who survived murder attempts were stalked.
- Intimate Partner Stalkers Are More Likely to Reoffend. Intimate partner stalkers are also more likely to: have criminal records and abuse drugs and/or alcohol; follow through with threats of violence; and assault third parties.

Many victims of stalkers reach out to law enforcement for assistance. And, while criminal charges may be an option, another lesser known, but extremely valuable service available for stalking victims includes the **Address Confidentiality Program (ACP)**. This program was created by law in 1998 and is operated by the Division on Women at the New Jersey Department of Children and Families. In addition to stalking, victims of domestic violence, sexual assault, and reproductive health patients and providers are also eligible for this program. ACP works by safeguarding the physical addresses of certain victims of crime and providing them with a substitute address to use when interacting with public and some private agencies. This means participants can use their substitute address on a driver's license, when filing for unemployment, registering to vote, enrolling in schools, obtaining a library card and filing a police report.

After meeting all eligibility requirements, applicants are officially enrolled and provided with an ACP card to use. The law states all public agencies must utilize the substitute address when creating a public record *unless* there is a bona fide statutory purpose for collecting a physical address. In this case, public agencies can only use the address for that one purpose and **must safeguard the address at all times**.

Abusers employ many strategies to locate their victims, but searching public records is one of the most common ones.

### **How You Can Help:**

- a. If you or your agency come across a stalking victim, among any other legal supports you may provide, please recommend the Address Confidentiality Program. It is a useful tool to help protect anyone who has concerns about being located. They do not need a restraining order to participate.
- b. If you encounter an ACP participant in the course of your work, you can ask to see their ACP card. Use the substitute address for administrative purposes or on forms accessible to the public.
- c. If you do require an ACP participant's address, safeguard this address and redact where possible in official documents to protect the individual's confidentiality and safety.

# What to Know: Sharpening Your Strategy With ARPA Funding Guidelines

The <u>ARPA funding guidelines</u> are coming into focus and we know one thing for sure: The reporting requirements are complex. This points to a need for increased accounting support and accuracy, and the role of better technology for our local governments becomes more critical than ever.

### The Basics of ARPA Funding Guidelines on Reporting

As you begin planning fund spending and gathering citizen input, it's just as important to start a reporting process that follows ARPA guidelines and prepares your team for the imminent audits. Here are a few ways to start aligning your team with the ARPA guidelines on reporting.

### 1. Understand Your Government's Specific ARPA Guidelines

Reporting requirements vary by government population and award size. Here are the four specified reporting levels for various governments.

- Metropolitan cities and counties over 250,000 residents
- Metropolitan cities and counties under 250,000 residents who received more than \$5 million in CLFRF funding
- Metropolitan cities and counties under 250,000 residents who received less than \$5 million in CLFRF funding
- Non-Entitlement Governments

Add Federal Expenditure Categories to Your Chart of Accounts

Treasury has designed an Expenditure Category (EC) methodology for organizing government efforts as projects. Six major ECs are tied to the allowable uses of Coronavirus Local Fiscal Recovery Funds (CLFRF). Within each category there are one or more detailed ECs. The reporting model requires that each project or service be listed under a single detail EC representing the focus of that activity.

Our OpenGov Suites make adding these ECs to your chart of accounts simple. Once added, you can:

- Use the porting function to facilitate your EC and non-financial preparations for Treasury portal reporting.
- Create reports which summarize expenditures by project and EC codes.
- Upload end-of-period Open Purchase Order data from your procurement systems and use OpenGov reports to summarize purchase order obligations by project and EC.

Include Cloud-Based Transparency in Your Reporting Plans

Reporting requirements reflect the need for transparency and accountability, while recognizing and minimizing the burden, particularly for smaller local governments.

To provide public transparency on infrastructure projects and show/prove that you are using practices that promote on-time and on-budget delivery, Treasury requires information from recipients on their workforce plans and practices related to water, sewer, and broadband projects undertaken with Fiscal Recovery Funds.

# **Applying Advanced Analytics To Public Sector**

In 2020, after decades of decline in crime rates, the U.S. homicide rate experienced the most significant single-year increase in more than a century. More than 50 cities of varying sizes across the U.S. saw an average 35% jump in murder from 2019 to 2020.

Additionally, the Centers for Disease Control and Prevention's National Center for Health Statistics found that overdose deaths increased more than 18% from the 12 months ending in June 2019 to the 12 months ending in May 2020. This reflects the largest number of drug overdose deaths ever recorded over a 12-month period.

As communities across the U.S. face an increase in crime, drug use, mental health issues, and homelessness, citizens are calling for change, and their elected officials are searching for ways to address concerns. What innovative approaches can be used to improve public safety?

Data analytics can help our law enforcement agencies reduce crime, investigate criminal activity and curtail drug rings while helping the people who cycle through our jails, mental health facilities, and homeless shelters. In fact, much of the data needed to promote safety is already collected and stored within the many computer systems that law enforcement agencies use today. Putting that data to work through integration — the act of bringing data from different systems together — and analysis can profoundly impact a community.

When approaching the use of analytics holistically across an organization, the integrated data can address various challenges, and one set of tools can be used for multiple purposes. For example, the same technology that uncovers illicit drug rings can also be used to understand the high utilization of social services. Referred to as a "data analytics platform," this approach maximizes the use of your data while minimizing the effort and cost of performing analytics.

A comprehensive data analytics solution for law enforcement involves:

- Automated data imports to bring data from multiple data sources together in near-real-time.
- The ability to detect and pull out the people, places, and things from narrative text such as incident reports, calls for service, social media, and SMS/text messages.
- User-defined and predefined geo-spatial search capabilities to search and retrieve data containing geo-coordinates.
- Machine learning algorithms that automatically prepare data for investigational and analytical use, ensuring that people, places, things and events are accurately identified.
- Algorithms that uncover non-obvious and hidden relationships between people, places, things, and events as well as obscure crime patterns across all data sources.
- Relationship charts that are generated automatically by extracting and matching entities that exist across multiple systems.
- The use of statistical, geo-spatial, and temporal attributes to display information in maps, trend lines, network links, and other visualizations to make identifying trends, spikes, outliers, and relationships easy.
- The ability for officers to create and modify surveillance and corresponding alerts as new crime trends and patterns emerge.

Increased crime and social issues do not need to overwhelm our public safety officials. With the use of data analytics, we can help our officers perform their work.

### **Cyber Liability Insurance and Cisco DUO**

While the risk of a city employee clicking on a foreign prince's secret gold offer may be past us, modern-day technologies have evolved and expanded in today's remote work and IoT-connected settings. It's hard to wrap our heads around every new risk out there; nowadays a single well-intended click of a GoFraudMe link can download malware that locks and holds your data for ransom. Unless every employee is on-boarded with good Back-up practices, the fee to get a decryption key is high (and probably Bitcoin). The advancing ransomware business is a threat not just for the big guys, but for organizations of every size.

Verizon's most recent Data Breach Incident Report, instances of advanced ransomware have doubled in the past year, alongside major upticks in phishing attacks and social engineering. A new landscape of data and cloud-enabled business has forced us to think differently about what to protect — namely the key personally identifiable information (PII) and personal health information (PHI) that can be accessed through corporate and remote networks.

This era of unpredictability has increasingly resulted in companies looking for ways to protect themselves and their employees in the event of a breach. Don't worry though, there's already an insurance policy for that.

### What is Cyber Liability Insurance?

Cyber liability insurance, sometimes known as cyber insurance, is distinct from traditional commercial general liability and property insurance policies. In short, cyber liability insurance acts as a general line of coverage designed to mitigate losses and costs from a variety of cyber incidents, including data breaches, network damage, and the resulting business interruption.

While each provider's policy may differ slightly, cyber liability insurance generally deals with:

- Loss or destruction of data
- Damages to software/hardware
- Extortion demands to appease bad actors
- Breach incident response and crisis management
- Legal claims for defamation, fraud, and privacy violations (third-party coverage)


Many variables go into pricing, which ranges from \$500 to over \$50,000 per year. To determine what coverage is necessary, cyber liability insurers calculate cost and risk based on industry, width and depth of data coverage, and, most importantly, what security measures are already in place. # SAMHSA Announces Unprecedented \$30 Million Harm Reduction Grant Funding Opportunity To Help Address The Nation's Substance Use And Overdose Epidemic

The Substance Abuse and Mental Health Services Administration (SAMHSA) is now accepting applications for the first-ever SAMHSA Harm Reduction grant program and expects to issue \$30 million in grant awards. This funding, authorized by the American Rescue Plan, will help increase access to a range of community harm reduction services and support harm reduction service providers as they work to help prevent overdose deaths and reduce health risks often associated with drug use. SAMHSA will accept applications from State, local, Tribal, and territorial governments, Tribal organizations, non-profit community-based organizations, And primary and behavorial health organizations.

With overdose deaths exceeding 100,000 over a 12-month period for the first time, this funding opportunity will provide support to those working in their communities to reduce the harms of drug use. Providing funding and support for innovative harm reduction services is in line with the Biden-Harris Administration's ongoing efforts to address the overdose epidemic, and is a key pillar for the first time in the multi-faceted Health and Human Services' overdose prevention strategy announced in October. This funding allows organizations to expand their community-based overdose prevention programs in a variety of ways, including distributing overdose-reversal medications and fentanyl test strips, providing overdose education and counseling, and managing or expanding syringe services programs, which help control the spread of infectious diseases like HIV and hepatitis C.

"The reality is, evidence-based harm reduction services are out of reach for far too many people," said National Drug Control Policy Director Dr. Rahul Gupta, who also announced a new model law to help states ensure access to safe, effective, and cost-saving syringe services programs. "Building on the Biden-Harris Administration's efforts to expand evidence-based prevention, treatment and recovery support services, this historic funding will help make harm reduction services more accessible, so we can meet people where they are and save lives."

"Too many Americans, more than 100,000 people over the last year, have lost their lives to drug overdose. Our new HHS Overdose Prevention Strategy is clear — harm reduction services are critical to keeping people who use drugs alive and as healthy as possible," said Health and Human Services Secretary Xavier Becerra. "Americans deserve health services that address the full range of drug use and addiction issues, and this funding will help provide those services in the neighborhoods in which they live."

"Innovative harm reduction services will help keep Americans alive," said Miriam Delphin-Rittmon, Ph.D., the Assistant Secretary for Mental Health and Substance Use and the leader of SAMHSA. "Thanks to this American Rescue Plan funding, harm reduction service providers in historically under-resourced communities will receive long-awaited support to help stem the disproportionate number of overdose deaths and related health issues facing those communities."

SAMHSA will distribute \$10 million per year over the next three years. Grant recipients must use the funds to support harm reduction services. Harm reduction service providers will be asked to develop or expand evidence-based services that may include, but not be limited to: the provision of sterile syringes, safe sex kits, prevention education about synthetic opioids and other substances, overdose prevention kits including naloxone distribution, peer worker engagement, medical services, case management and referral to treatment. Warm handoffs that facilitate engagement in care and referrals to treatment for individuals seeking these support services are also critical components of this grant program. Harm reduction services will be trauma-informed and guided by harm reduction stakeholder groups and other community members.

# Nationwide Economics Weekly Economic Review & Outlook for December 20, 2021

### **Weekly Review**

### An earlier end to easy monetary policy

The Federal Reserve took a much-anticipated hawkish pivot at the FOMC meeting last week in a clear signal that inflation is becoming more concerning, as it continues to run well above the Fed's 2.0 percent goal. This comes as data on economic activity were mixed, perhaps showing a moderating of activity into year end. Retail sales rose by less than expected while housing starts and building permits surprised to the upside. Regional manufacturing activity along with global slash PMIs showed a moderation of activity and an easing of supply constraints, as evidenced by slower price gains.

### The FOMC shows increasing concerns about inflation

At last week's FOMC meeting, the voting members decided to leave short-term interest rates unchanged but sped up the tapering of asset purchases, which should now end by the middle of March 2022 (rather than in May). This move to speed up tapering will provide the FOMC with the optionality to raise short-term interest rates earlier than had been expected, as the Fed would not raise rates while still purchasing longer-term Treasury notes and AAA-rated MBS. In the latest summary of economic projections (SEP) released last week, the committee appears more likely to take advantage of that optionality with median estimates now indicating three 25 basis point hikes in 2022, three more 2023, and two in 2024-bringing the federal funds rate up to around 2.00 percent by the end of 2024, compared with 0.00 percent today (lower bound).

During the press conference following the FOMC meeting, Chair Jerome Powell emphasized that the economic recovery has been strong, the labor market is healing, and inflation has been both well above the target and more persistent than expected. His comments around these topics, along with the concerns he raised about stronger wage gains (shown in faster growth in the employment cost index), have raised speculations that the Fed could raise short-term interest rates before its maximum employment estimate has been met. While there is no clear measure that defines maximum employment, the fact that inflation estimates were raised substantially for 2022 in SEP, and consistent commentary from many Fed speakers expressing concern about persistently high inflation rates, increases the likelihood of earlier rate hikes. Longer-term interest rates typically rise when the Fed tightens (although by less than short-term rates move higher), but with the 10-year Treasury note yield at around 1.40 percent, there are increasing risks that too much Fed tightening in coming years could cause a yield curve inversion (when short-term rates rise above long-term rates). This has been an excellent predictor of economic downturns historically.

#### Mixed economic data for November

Retail sales rose by less than expected for November, but with upward revisions for October, as shoppers heeded the call to purchase early for the holiday season. Sales at electronics and department stores both declined while sales at gas stations, and for food and sporting goods led the increase. These numbers are usually volatile month-to-month anyway, and with the uncertainty around Covid and supply chains, that volatility is likely to remain high.

Housing starts and building permits were up strongly for November. Housing activity remains an area of the economy that continues to do well despite headwinds from supply chains and lack of inventory. Fundamentals are strong, and with significant excess demand it likely will take a substantial rise in interest rates to slow housing demand substantially.

Regional Fed manufacturing surveys and global flash PMIs showed some moderation in activity last month. Of note was the easing of some supply chain issues globally which helped to reduce the prices paid metrics. It will still take much more healing to get back to normal, but that now appears to be underway.

### **The Week Ahead**

### Existing home sales expected to edge higher

Existing home sales climbed to their highest level since January in October, boosted by strong underlying demand factors (e.g., low unemployment rates, rising incomes, and low mortgage rates). These factors were present for November, as well. In addition, October pending homes sales (which measure contract signings and so lead reported existing sales by one to two months) climbed in October to their highest level since the market was booming at the end of 2020. We project that the annualized pace of existing home sales rose to 6.39 million units for November-the fastest pace since January.

### New home sales also expected rise modestly

In addition to the factors noted above helping to boost overall housing demand, new home sales should also benefit from the historically low supply of existing homes for sale-shifting some of the strong demand toward new sales. A rise in the present sales component of the NAHB's housing market index also suggests that sales should increase. But a small drop in the MBA's purchase applications for new homes may offset some of this impact. We project a modest increase in the annualized pace of new home sales for November to 751,000 units, the fastest pace since April.

### November's core inflation could be the highest since 1989

Consumer spending likely slowed but remained solid for November. Based on the most recent retail sales report, there was a shift in consumer activity away from goods (where electronics and appliance stores saw sales pull back sharply) to services (where restaurant spending picked up) Other services spending not measured in retail sales should also have increased for the month. We project a rise of 0.7 percent for personal

consumption expenditures (PCE), roughly half of October's gain. Personal income also should have increased by around 0.7 percent, keeping the saving rate little changes. Inflation continues to run hot, and we project this translated to a 0.4 percent monthly gain in the core PCE price index, which would bump the 12-month growth rate up to 4.6 percent-the fastest year-over-year growth in this inflation measure since early 1989.


