Morris County Park Commission Receives Prestigious Award

- Seward Johnson Exhibition at Willowwood Arboretum Cited for Excellence by Denise Lanza, Assistant Deputy Director for Morris County Park Commission

The Morris County Park Commission received the Excellence in Special Events Award from the New Jersey Recreation and Park Association (NJRPA) for "The Living Sculpture: A Seward Johnson Exhibition at Willowwood Arboretum," a special installation that was open daily to the public from July until November last year.

"Congratulations to the Morris County Park Commission on receiving the distinguished award from the NJRPA. This certainly was a unique exhibit featured at the Willowwood Arboretum and I know a lot of work went into coordinating it. Everyone involved in putting this special project together for the public deserves to be applauded," said Morris County Commissioner Doug Cabana, liaison to the Morris County Parks Commission.

Johnson, known for his life sized and large-scale bronze sculptures that depict everyday life, was born in New Jersey in 1930. He founded the Johnson Atelier Technical Institute of Sculpture in 1974 and The Grounds for Sculpture Park and Museum in 1992, both in Hamilton, N.J.

"The goal of Morris County's 'The Living Sculpture: A Seward Johnson Exhibition' was to bring art to the average citizen. Although the Johnson sculptures are available for regular public exhibits through the Johnson Atelier, it is somewhat unusual for a park system to be able to provide such access," said David Guida, an NJRPA Awards Committee Member. "Johnson's vision is to make sculpture accessible to all; how fitting that the Willowwood Arboretum exhibit was able to do just that."

Morris County Park Commission Assistant Deputy Director Denise Lanza accepted the award presented by Guida during the NJRPA Annual Awards Dinner on February 27 in Atlantic City.

"Parks have an essential purpose in bringing communities together," said Lanza. "That we could exhibit Johnson's artwork in a natural setting and make it available for the public to enjoy is a testament to that objective."

Monmouth ACTS Launches Integrated Navigation System

County Monmouth County Board of Commissioners. Monmouth ACTS Community Partners, representatives from the Monmouth County Department of Human Services and other members of Monmouth County leadership gathered to announce the launch of the Monmouth ACTS Navigation System – a streamlined method of connecting residents to needed services and support. The Navigation System, which integrates live support with a state-of-the-art electronic referral system, is the first of its kind in the state.

"It is the shared mission of our Monmouth County government and the many agencies and organizations throughout the County to provide easier access to services for our residents," said **Monmouth County Commissioner Director Thomas A. Arnone**. "We are proud to offer this program to our residents, so that with one phone call, they are able to find resources for food insecurities, housing stability, mental health care, employment services, childcare and much more."

The Navigation System is the latest initiative from Monmouth ACTS, which strives to better connect Monmouth County residents with services that will improve their lives. A fully integrated electronic referral system, residents can call the Navigation System "Warm Line," a phone line that is staffed by several trained and compassionate social workers and be directly connected to potential resources throughout the County. The Navigation System was created to reduce information overload, improve access, follow up and connections, and track results for residents.

Residents may call the Warm Line at 732-683-8959 Monday through Friday between 8:30 a.m. and 4:30 p.m. A social worker will ask the resident questions to better understand their unique needs, before connecting them to potential resources in the Monmouth County area, including County Departments and Divisions, social service agencies and the many organizations that make up Monmouth ACTS. If the resident grants permission for their information to be shared, the social worker can refer the resident to services directly, and ensure that an agency is following up with the resident to meet their needs via an electronic referral and tracking system.

"We have always said, "There is no wrong door to access services in Monmouth County," said **Commissioner Susan M. Kiley, liaison to the Department of Human Services**. "What's amazing about the Navigation System is that it is truly one door, or one phone number, through which you'll find countless potential services. Our trained and compassionate social workers will carefully work with our residents and personally guide them to or connect them directly with a multitude of services. This means that with one phone call, residents can receive assistance for multiple needs simultaneously."

The Navigation System allows the social worker to determine the type of referral based upon the resident's needs: The social worker may decide to transfer the resident to an agency(s) via a three-way call or may need to act as coordinator of multiple agencies and services if the resident's needs are significant and complex.

Monmouth ACTS leadership has also set expectations and goals for participating agencies and partners – agencies must contact residents within two business days of receiving the electronic referral, and after 30 days agencies must update the Navigation System with results and information, including if the resident's needs were met.

"The launch of this ground-breaking Navigation System would not have been possible without the support of the Monmouth County Board of County Commissioners, the hard-working Office of Monmouth ACTS team, and the determination of the staff within the Department of Human Services," said **Peter-Donnell Boynton, Chair of the Monmouth ACTS Advisory Council (MAAC) and Director of the Monmouth County Department of Human Services**. "We're continuing to listen closely to our residents about their needs, in order to provide them with new initiatives such as this and continue to serve them better, together."


