What IS A Telecom Consultant, Why Do You Need One, And How Do You Choose The Right One?

As David Byrne said, "You may ask yourself..." (end Talking Heads reference) – What is a Telecom Consultant and why do they keep calling me? You wouldn't be alone.

Municipal and County officials are quite familiar with the "legacy" professionals – attorneys, engineers, and various other professionals. They are all very important, and important to know about.

While "Telecom Consultant" may be a less-known term or concept, the potential for one to add tremendous value to your County or Municipality exists nonetheless.

First, what does one do? Generally, a Telecom Consultant refers to an entity that manages matters of wireless telecom infrastructure and related matters. These are generally not the type of consultant who would set up phone systems in your offices.

What are wireless telecom infrastructure matters? Services provided could include anything from ordinance advisory services (ensuring proper and desired use of your public spaces), to site audits (ensuring lease entitlements are being honored and rents are current), to permit reviews (site modification rules can be somewhat nuanced, it's best to have expert eyes on these), to bid writing and contract negotiations for new and existing tenants.

Why do these things matter to me?

• Ordinance Advisory Services: A Telecom expert should have the knowledge and ability to work with your attorney to provide or help draft language that will offer the maximum enforceable protections for use of your public spaces. If your residents don't mind looking at unfettered antenna and cable clutter proliferating on your wood poles, this may not matter to you. If aesthetics matter to your County or Town, have an expert work with your attorney to understand what can and can't be governed, and the implications from putting rules in place or not doing so. Many towns we've spoken to have decided this wasn't important only to find themselves in a corner once the first carrier ROW applications arrive.

What Is A Telecom Consultant, Why Do You Need One, And How Do You Choose The Right One? (continued)

- Site Audits: Does your County have any lease rights with wireless carriers? Do you own water towers, monopoles, lattice towers, or buildings that have or might have the ability to house wireless infrastructure? A good Telecom Consultant will perform an assessment of your physical assets, lease rights, and tenant compliance with the same to ensure you're receiving the right rent or revenue share, and that you're not missing any opportunities for additional passive monetization! Of the audits performed by ACE Telecom in 2023 and 2024, we discovered over 50% of tenancies were in some way out of compliance. A good Telecom Consultant will leave you with a clear picture of your assets, risks, opportunities, and overall values.
- Permit Reviews: These are not typical buildings or deck additions, there are many industry-specific aspects of telecom infrastructure that should not be overlooked (distance from power lines, size increases related to Eligible Facilities Request
- Bid-Writing/Contract Negotiations: We've seen public entities accept lease buyout offers without publicly bidding. We've seen public bids with 2-3 respondents. We've seen bids with no respondents due to overly restrictive requirements. ACE Telecom Consulting or a similar consultant can help identify potential tenant interest at a location, write the bid, ensure all appropriate parties (not just those following public notices) are involved, driving up value through maximum competition.

"Okay", you say to yourself, "We need a Telecom Consultant, so how do I choose the right one?" The answer is clearer than you might expect. Ask yourself these questions:

- What is their experience level not just in number of years or volume of contracts, but breadth of discipline. Is one only a specialist on legal or engineering matters or can they help me on all the other important components?
- Do their references check out like any of us, if you're giving someone a contract, you expect them to pick up when you call, to commit to a level of performance you would be happy with. What do their references say about them?
- Do they have conflicts? Can someone objectively represent us while also representing carriers or industry groups in other matters?
- Can they find revenue opportunities? That's the million or several-million-dollar question. A good Telecom Consultant will help you find ways to bring in the most revenue possible, making their services a net benefit to your County.

This organization seeks to inform and educate the public on the trade's numerous public benefits, using hard data and specific examples. More than that, we want to speak directly with residents and stakeholders about the industry and how it can continue to act as the life force behind New Jersey's economy.

Logistics take in goods and services from across the world. We then create jobs, economic growth, professional development, and environmental rehabilitation opportunities before providing goods and services directly to your doorstep. New Jersey benefits significantly from the logistics industry, in terms of real dollars but also in terms of economic opportunities for our residents and environmental stewardship.

The logistics industry includes a huge portion of New Jersey's economy, from port workers, distributors, developers, construction professionals, to trucking companies and more.

Economically, logistics supports over 400,000 New Jersey jobs and is one of the state's fastest growing employment sectors. That amounts to 12% of the state's workforce. Logistics accounts for 12.7% of New Jersey's private sector wages, offering an average annual salary of \$75,000. The industry also contributes \$62.5 billion, or 10%, to the state's Gross Domestic Product.

In addition to the economic benefits, the logistics industry often serves as a hub of innovation. While many might look at a storage facility or data center and simply see a square, mundane building, inside there are individuals working on improving and creating the latest technologies for safely and efficiently moving goods and services through New Jersey.

New Jerseyans might be surprised to learn that the logistics industry is actually a leader in the environmental cleanup of polluted brownfield sites. Unusable to the public without rehabilitation, logistics industry members have created clean up and reuse opportunities up and down New Jersey.

It's not, however, just about economic growth and environmental rehabilitation, as critical as those both are. It's about the little moments and experiences in our lives that happen because of logistics.

The Thanksgiving meal that many of us were lucky enough to enjoy with friends and family, the gifts we give and receive during the holidays, the ability to get what you need for your child's school project or replace that kitchen appliance without spending time that you don't have driving to the store – all of that is possible because of the logistics industry.

Exciting News! Through Family Connects NJ, Families Welcoming Home A Newborn In New Jersey Can Now Request A Free In-Home Nurse Visit In Six Additional Counties, Starting January 2025!

The Family Connects NJ program connects families in 11 New Jersey counties with a free in-home visit by a specially trained, registered nurse within the first two weeks of welcoming home a newborn. This service, which launched last year, extends to birth families, as well as to foster and adoptive parents. The program is

also available to families that have experienced the tragedy of stillbirth or neonatal loss.

As of January 2025, the Family Connects NJ program is serving families in Cumberland, Essex, Gloucester, Mercer, Middlesex, Somerset, Sussex, Passaic, Hudson, Bergen, and Ocean Counties. Additional counties will be added in the future.

Universal Home Visiting

Family Connects NJ is a free, voluntary program offering a visit at home by trained nurses for any family caring for a newborn baby. The program is available to all New Jersey families.

During the critical first weeks following childbirth, Family Connects NJ provides families with a private visit at home by a specially trained nurse. Program nurses will check the baby's weight, assess physical and emotional health of both newborn and parents. Family Connects NJ nurses also provide information on important topics like feeding, sleeping, and community resources available, if needed.

How to Enroll

Families can learn more information and request a nurse visit by visiting the **Family Connects NJ website**. For families who would rather enroll by phone, the website also includes phone numbers for local Family Connects NJ nurse providers in your home county.

Program Highlights

- Care is provided at no cost to you, in the comfort of the family home, and is completely voluntary.
- Services are available to birth, adoptive, and resource families with a newborn, as well as parents experiencing a stillbirth or loss of their newborn.
- While Family Connects NJ will initially be limited to select counties, it will gradually expand service to all of NJ. Visit FamilyConnectsNJ.org/rollout for more information.
- Specially-trained registered nurses evaluate health, screen for potential complications, answer questions, and address any unexpected changes families are experiencing during the first two weeks after delivery.
- Nurses will connect families to community resources based on their specific circumstances.

Grant Opportunities

- Up to \$75 million in funding is available through the NOAA <u>Restoring Fish Passage through Barrier Removal</u> grant. These funds will be used to remove dams and other in-stream barriers, reopen migratory pathways, and restore access to healthy habitat for fish around the country. NOAA will accept proposals between \$750,000 and \$8 million for the entire award, with typical funding anticipated to range from \$3 million to \$5 million. **APPLICATION DEADLINE: FEBURARY 10, 2025.**
- Up to \$20 million is available for fish passage and tribal capacity building under the NOAA Restoring Tribal Priority Fish Passage through Barrier Removal funding opportunity. This funding will support U.S. federally recognized tribes, Alaska Native Corporations, and tribal organizations in building tribal organizational capacity and implementing projects that reopen migratory pathways and restore access to healthy habitat for tribally-important species. NOAA will accept proposals between \$300,000 and \$6 million for the entire award, with typical funding anticipated to range from \$500,000 to \$4 million. APPLICATION DEADLINE: FEBURARY 27, 2025.
