Job Description

The Middlesex County Office of Planning seeks a detail-oriented and self-disciplined professional to join its Sustainability and Resiliency team as Principal Planner. The position provides an excellent opportunity to work on projects and initiatives for a more resilient and sustainable future, including stormwater management, climate change, flood mitigation, and wastewater and water quality planning.

The Principal Planner will assist in the preparation, coordination, and management of various special planning projects and critical regulatory work. A key project will be the recently awarded \$1.2-million grant for a consultant-led regional flood mitigation study involving multiple municipalities and other stakeholders to improve flood resiliency in the region.

This position is vital to advancing the County's long-term sustainability and resiliency goals and Destination 2040 initiatives. The ideal candidate should be a solution-oriented team player with solid project management skills, excellent communication abilities, a proven track record of success, and a passion for impactful, community-oriented sustainability and resiliency work.
